INSTRUCTIONS FOR OBTAINING A GET - JEWISH DIVORCE

Please bring the following documentation if and when easily available.

- 1) **An I. D.:** A driver's license or a passport. Or teudat zehut.
- 2) **The Ketubah** (religious marriage document). A picture of your Chupah .
- 3) If applicable, documentation of conversion .
- 4) If your civil divorce is final or is in the process, a copy of the front page,(not the settlement).
- 5) If applicable: Previous divorce documents and /or Get.

FEES: The standard fee, when both parties come together for a Get, is \$500.00, payable to BADATZ-WCRC. Where the Get must be done through messengers or sent out of town, it is from \$650.00 to \$1250.00. Higher fees may apply in exceptional circumstances. However if you need financial assistance, we can accommodate.

A non-refundable deposit of \$300.00 for the standard, or \$475.00 for messenger Get, must be included with this application, for the initial work, with the balance due at the time of the Get .This deposit is non-refundable. Please sign accepting the above terms: _____
